# Focus: New Business Models in Agri-Food Systems

The position is available from January 2026 for a period of 3 years and is based on a university employment contract (TVL-E13, 65%). The position is part of agri:change, an interdisciplinary research initiative on the sustainability transformation of the agri-food sector in Lower Saxony.

Within agri:change, four practice-oriented real-world laboratories (agri:labs) develop innovative solutions together with stakeholders. This position contributes to agri:lab X1 (Sustainable Value Chains and Transparency).

The successful candidate will work on the project "New Business Models in Agri-Food Systems: Income Alternatives through Biodiversity and Carbon Sequestration", which is a joint project between the chairs Economics of Sustainable Agri-food Systems (Prof. Dr. Doris Läpple) and Agricultural Economics, Hochschule Osnabrück (Prof. Dr. Nana Zubeck) The project explores how innovative business models for environmental services can be co-designed and tested together with farmers, food companies, and consumers.

- Design and conduct, interviews and surveys / economic experiments with farmers
- Conduct quantitative and econometric data analysis
